1. REQUIREMENTS FOR APPLICATIONS OF NAMIBIAN "CITIZENSHIP BY DESCENT.

NOTE: Incomplete forms and outstanding documents will cause unnecessary delays. All copies must be certified by Namibian police.

Only applicant himself/herself or legal Guardian is duly allowed to sign the application form.

## FORMS AND DOCUMENTS REQUIRED:

- 1.1. Application for Namibian citizenship {cross by Descent}.
- 1.2. Certified Copy of the applicant's full birth certificate and Namibian Id if in possession of such Id.
- 1.3. Certified Copies of both parent's Identity cards and birth certificates (born in Namibia).
- Copy of Repatriation form (if he/she was born in exile during the liberation struggle).
- 1.5. If such Repatriation is lost or impossible to get, a declaration from parents or Guardian made from the Namibian Police.
- 1.6. And Letter from SWAPO Party office confirming that the child was born in exile.
